Scope of Tender

The Senior Scientist & head, Deendayal Research Institute, Krishi Vigyan Kendra, Majhgawan ,Satna-485331(MP)(herein after referred as Tender Inviting Authority and/or Tender Acceptance Authority and/or Ordering Authority unless the context otherwise requires)Invites online bids(Two bid system) from registered contractor for Renovation of Seed Processing shed work at KVK, Majhgawan, Satna as below:

Eligibility Criterion

The Tenderer should fulfill the following eligibility criteria:

- a) The Tenderer should be registered manufacturer or authorized dealers having relevant License and such a Registration should be valid as on the date of Tender submission.
- b) The Tenderer should have achieved annual turnover as follows (every FY) in the last three financial years.

- c) The Tenderer (and tenderer's principal manufacturer, if tenderer is Authorized Dealer)should not be blacklisted either by the Tender Inviting Authority or by any State Government or by Government of India.
- d) The manufacturer should be in the business of manufacturing/ fabrication of similar items for a period not less than 5 Years.
- e) The Tenderer must submit the Form—"A" on letter head with signature & stamp. Annexure-1

Validity of Tender

- a) The Tender will be valid for a period of 10 DAYS after the due date of submission of Tenders. A Tender valid for a shorter period shall be rejected by the Tender Inviting Authority as non-responsive
- b) In exceptional circumstances, prior to the expiration of the Tender validity, the Tender Inviting Authority may request the Tenderers to extend the Tender validity for further period as deemed fit. The request and the

responses thereto shall be made in writing. A Tenderer, agreeing to the request will not be required or permitted to modify its Tender.

Preparation and submission of Tender

- a) The Tender should be Computerized and every correction and interlineations in the bid should be at tested with full signature by the tenderer, failing which the bid will be treated as ineligible. Corrections done with correction fluid should also be duly attested.
- b) Bidder should give all relevant particulars about every item and Price etc.
- c) Registered manufacturer/ authorized dealers should submit the certificate.
- d) All documents/papers should be numbered, signed and sealed by the Tenderer on each page.
- e) The Tender is required to be prepared and submitted in two parts viz. 'PartA-Technical Bid' and 'Part B Price Bid'.
- f) The 'Envelope of Part-A Technical Bid' shall contain all essential documents for Technical Tender. Such documents attached as per Annexure-1 to (Online).
- g) The **'Envelope of Part-B-Financial Bid'** shall contain duly filled, stamped and signed Price Schedule in the format provided in Annexure 3.
- h) The Online tenders as above should be submitted on kvksatna@dri.org.in as per Scheduled date and time.
- i) Tender submitted or received after the closing date and time will not be considered.

Tender Prices

- a) Tender has been called for in the names of Items. The Tenderers should quote the rates for the Items mentioned technical specification for fabrication of polyhouse and nethouse all equipment and machinery.
- b) The Tenderer should mention the name of work being quoted.
- c) The rates should be quoted in format of Price Schedule shown in **Annexure-5. Rates** quoted in any other format tender will be rejected.
- d) Rates inclusive of Excise Duty, Customs duty, transportation, insurance, and any incidental charges, but exclusive of State VAT/CST should be quoted for each of the required item, separately on door delivery basis (FOR Destination, at Stores) as per format of Price Schedule given in Annexure 5
- e) Quoted rates are valid up to one year from the date of signing of contract agreement and shall be firm during the currency of the contract.

Opening of Tenders

a) The Tenders shall be opened at the scheduled date, time and venue by the committee constituted by the Tender Inviting Authority. The Tenderers' representative may attend the Tender opening.

Technical Bid & financial bid shall be opened Online and Physical copy submitted by post to address of **Deendayal Research Institute**, **Krishi Vigyan Kendra**, **majhgawan**, **Satna** – **485331 (MP)**

- b) The date and time of opening of Price Bid shall be informed to such Tenderer who qualify in technical Bid evaluation. The tenderer's representative may choose to attend the opening of Price Bid.
- c) In the event, the date of opening as above is declared government holiday; the tenders shall be opened at the same time on the next working day.

Evaluation of Tenders

- a) The Evaluation committee, constituted by the Tender Inviting Authority, shall evaluate the tender with reference to technical requirements and various other commercial criteria given in the Tender Document.
- b) Tendering agency reserved the right to cancel; disqualify any tender despite being of low rate, if they not satisfied with the quality of products offered.

Placement of Work Orders and Delivery Requirements

a) The Tender Inviting Authority shall place work Order for fabrication/construction of Items with in the period of 15 days from the date of award of contract with successful Tenderer. Tender Inviting Authority reserves the right to extend the validity of work order further by 01 months on the same rates and terms & conditions of the contract.

The tenderer should complete the material supply at the Deendayal Research Institute, Krishi Vigyan Kendra, majhgawan, Satna – 485331 (MP) with in 20 days from the date of issue of work order.

- b) If at any time the Tendered has, in the opinion of the Tender inviting authority, delayed the completion of work due to one or more reasons related to force major events such as riots, mutinies, wars, fire, storm, tempest or other exceptional events, the time for completion of work may be extended by the Tender inviting authority/ordering authority at its discretion for such period as may be considered reasonable. However such extension shall be considered only if a specific written request is made by the Tendered within 7days from the occurrence of such event. The exceptional cause does not include scarcity of raw material, power cut and labour disputes.
- c) The undersigned reserves the rights for any changes /cancellation /rejection of any part or whole tender, without assigning any reason what so ever.
- d) Warrantee /Guarantee should be for period of minimum 3year.
- e) It must be noted that normally all correspondence and transactions will be made only with the parties whose tenders have been accepted and not with anybody else.
- f) The undersigned reserves the right to split up the order for supply of articles at tender for amongst more than one tender.
- g) The Tender inviting authority may ask for samples and demonstration of any particular item quoted by the bidders or being used in the nethouse and polyhouse. The bidders shall have to give Demonstration in the prescribed time limit. In case the demonstration of work item is not in accordance to the specification in the prescribed time it shall be open to the undersigned to

- forfeit Security Money Deposited by the bidder. If the sample work is approved, the same will be returned back to the party after the satisfactory completion report by the tendering authority.
- h) All works should be completed with quality. The undersigned may get the works inspected by such person or persons he deems fit and to reject such of these works as in his opinion do not come up to the satisfaction. The decision of the undersigned will be final in such cases.
- i) If any of the item work done by the tenderer, found to be' Not of Standard Quality', the tenderer should be able to complete the whole Item work again.
- j) Guarantee Certificate:-The Bidder will have to submit the GUARANTEE CERTIFICATE as per Annexure—4
- k) Warrantee /Guarantee should be for a period of minimum 3 year.

Payment Terms

a) The payments will be released in three installment, 50 % with the supply of materials, 30 % with sixty per cent of completion of work , 20% payment with successful completion of work and verification. However, if the work is not found as per specifications, then final payment will be withheld and shall be released only after satisfactory completion of work.

Settlement of Disputes

a) In the event of any dispute arising out of the tender or orders such dispute would be subject to the jurisdiction of Courts of Satna Madhya Pradesh nearest to the place of Tender Inviting Authority.
